

## THE 8TH HARM REDUCTION CONFERENCE

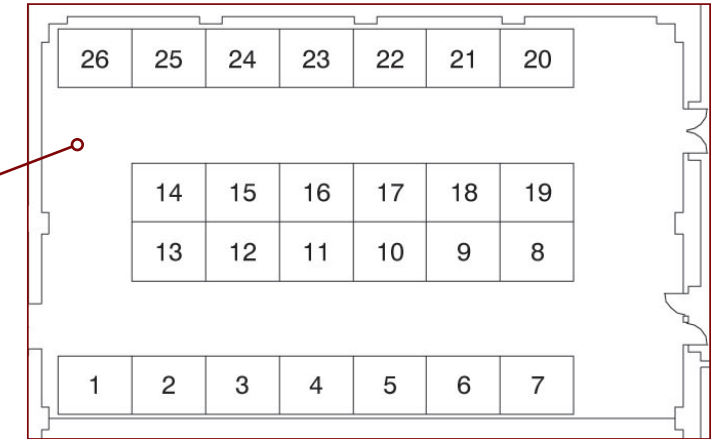
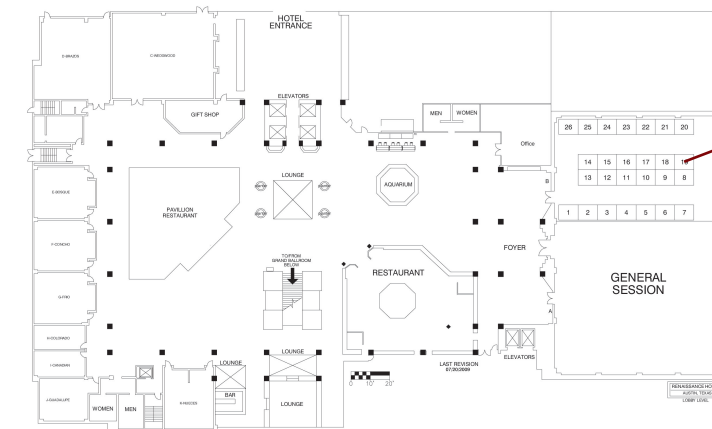
